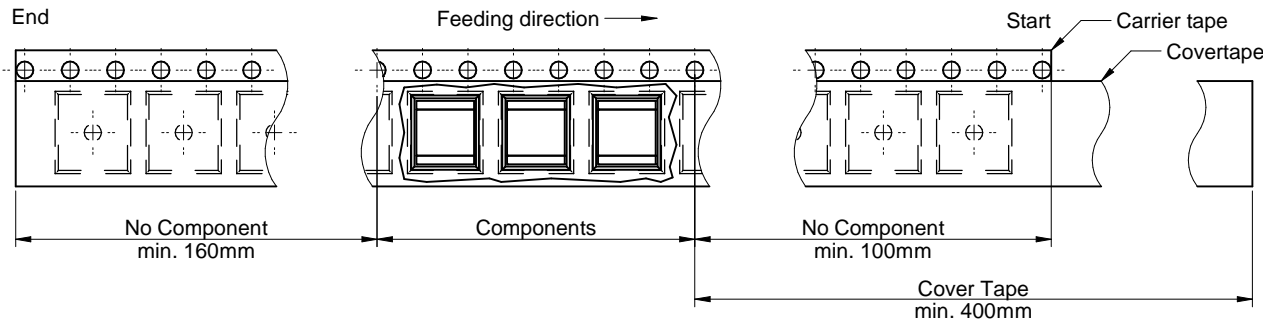
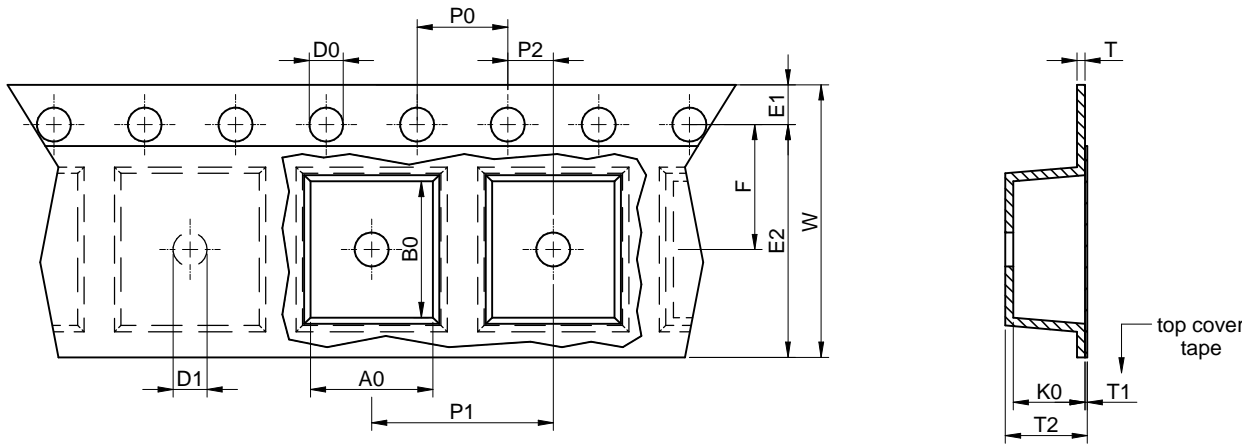
**Derating Curve:**



## Storage Conditions:


