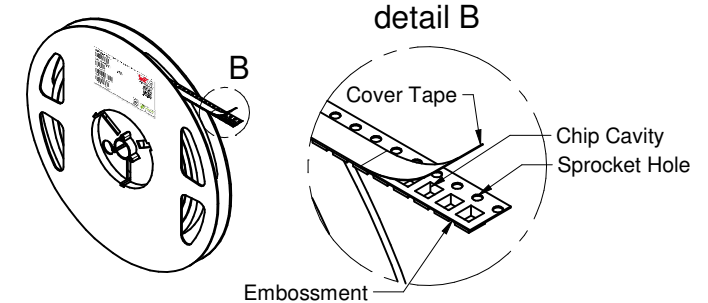
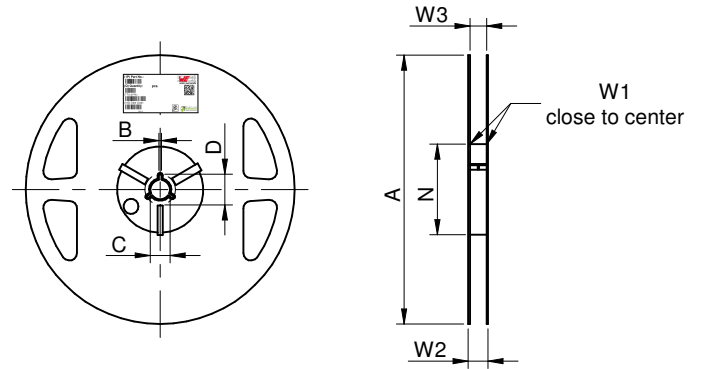
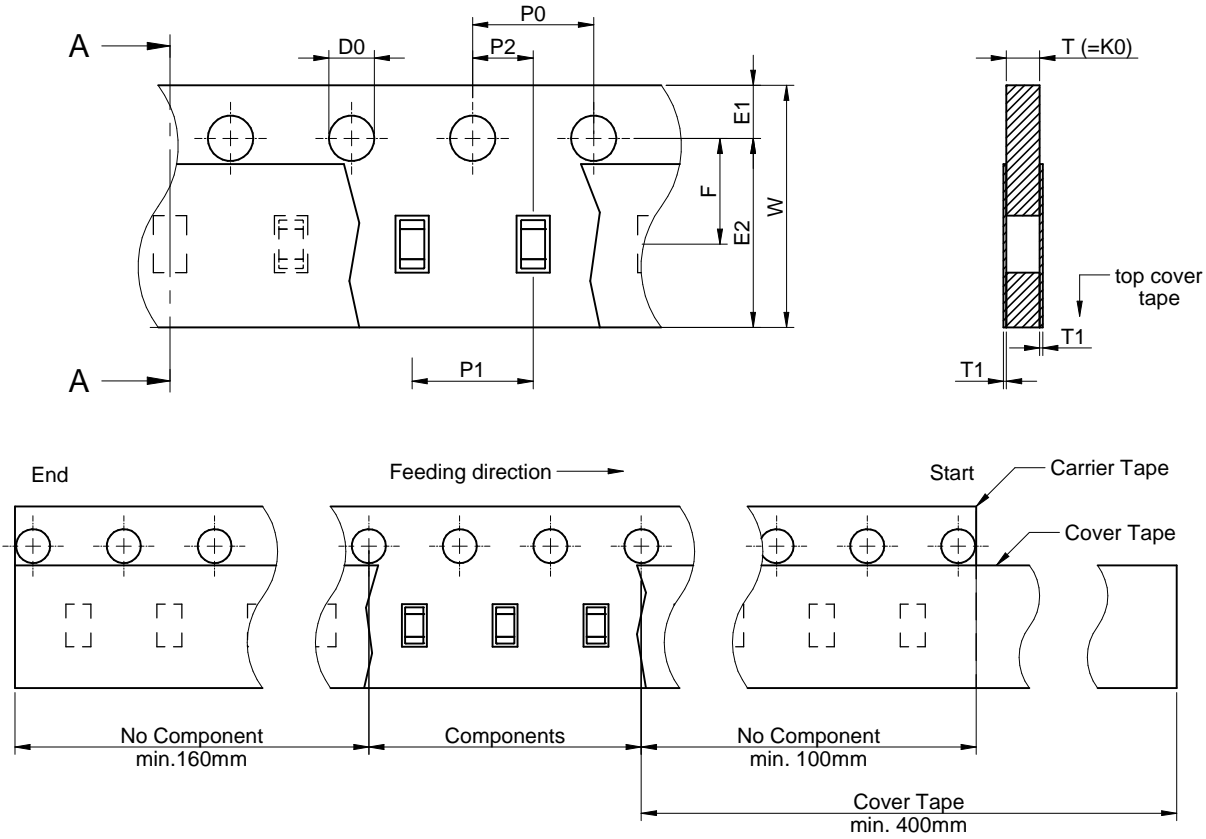
Derating Curve:




