Typical Insertion Loss:



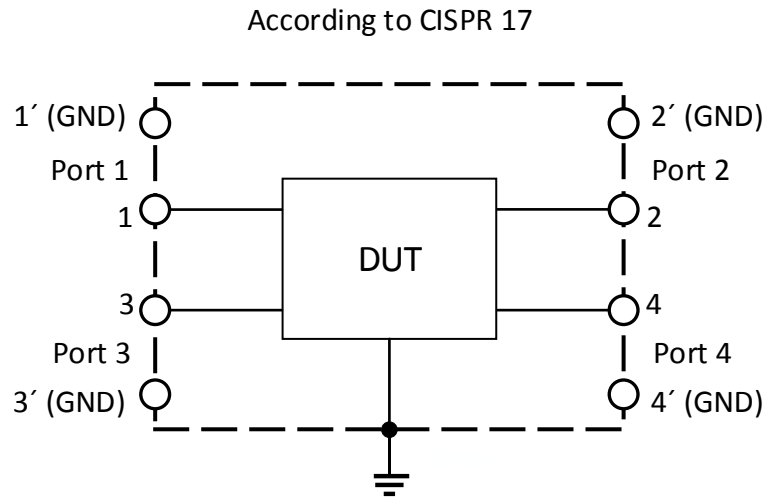
Typical Impedance Characteristics:

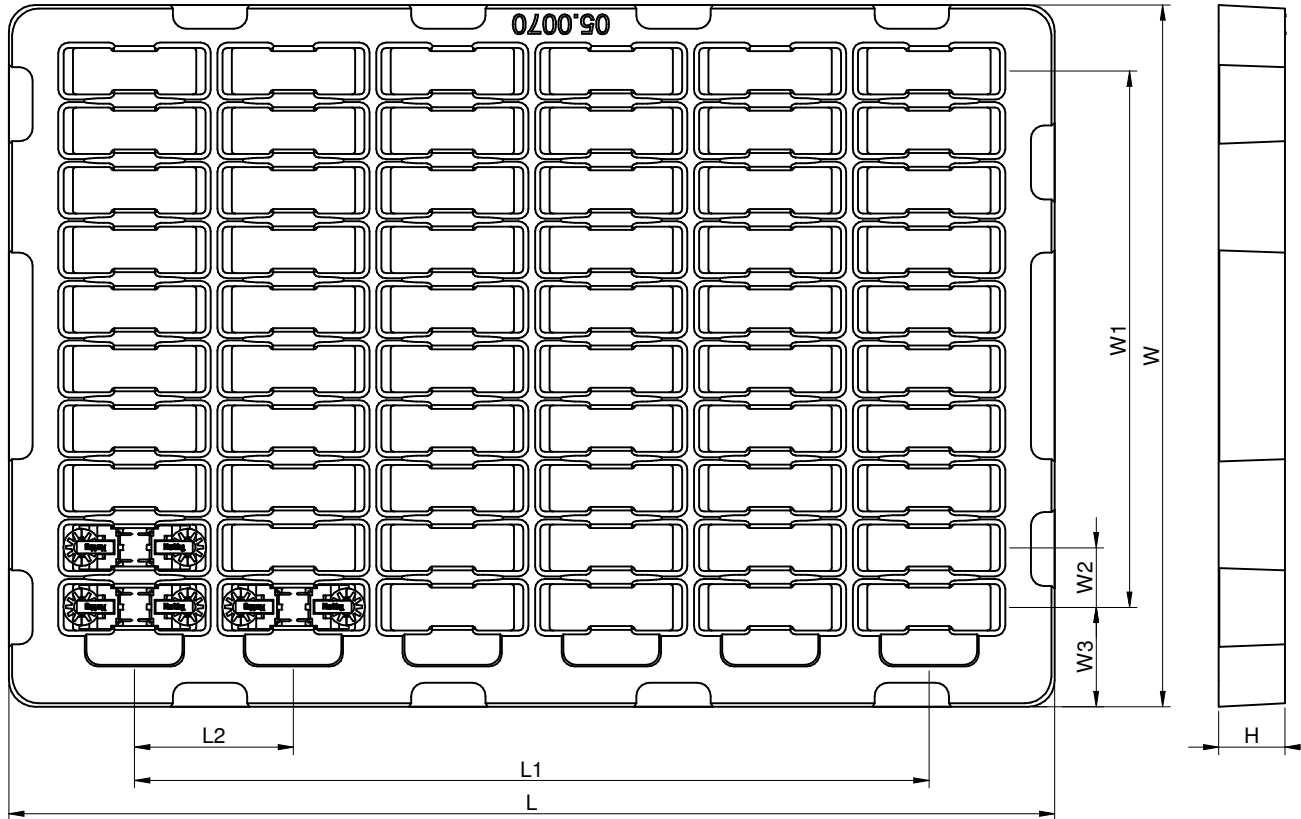

Derating Curve:

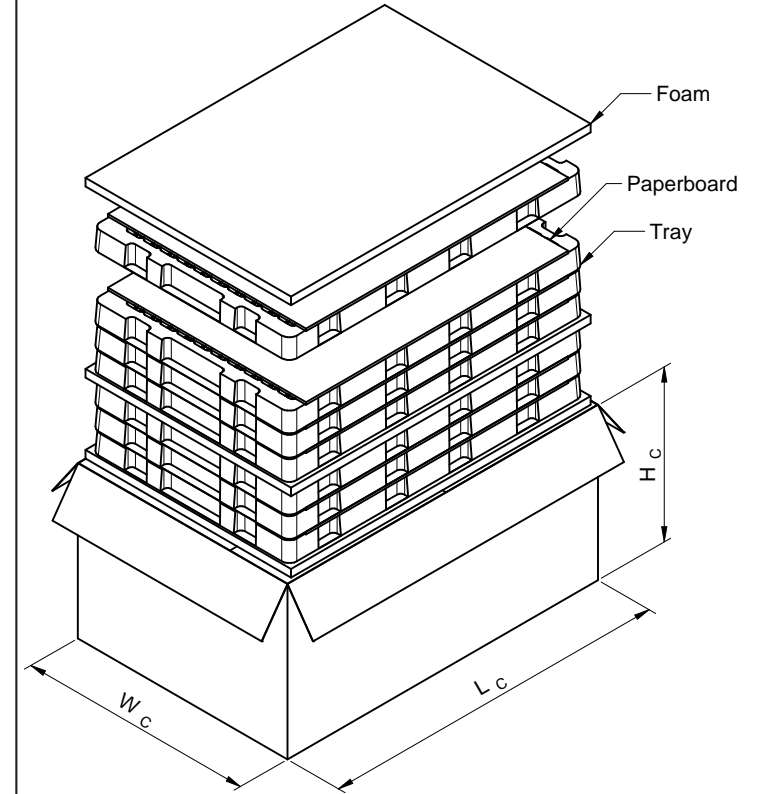

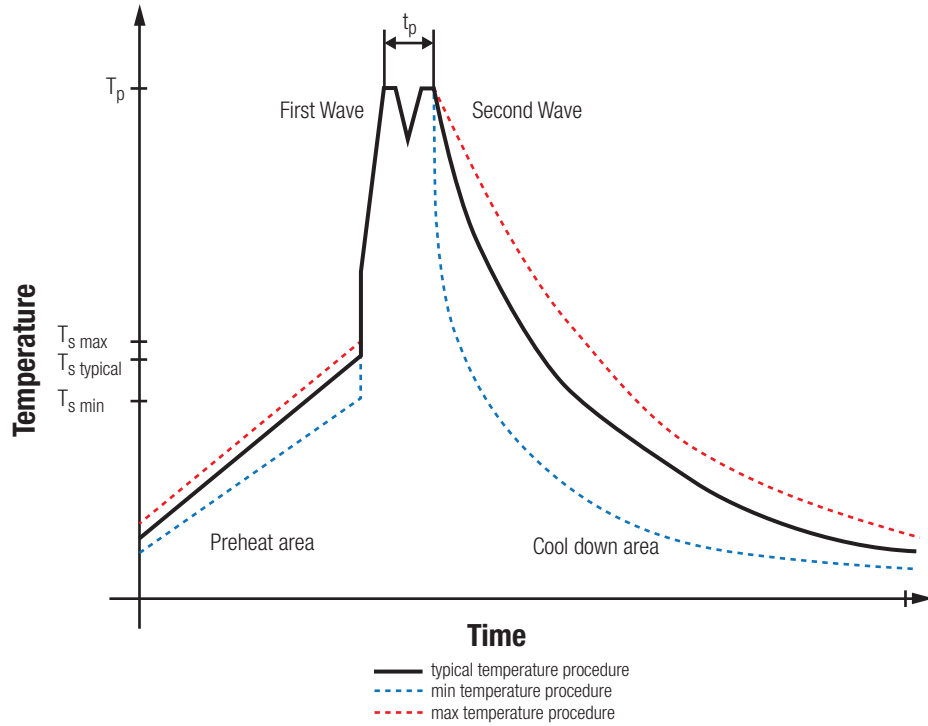

Soldering:




