### Typical Insertion Loss:



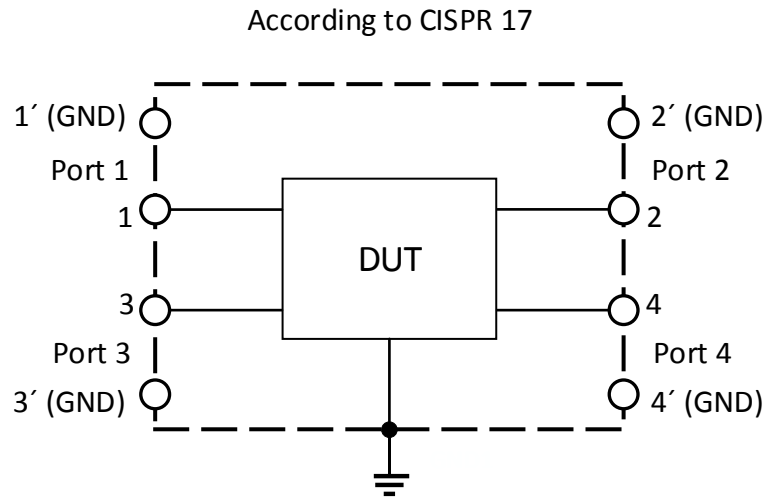
### Typical Impedance Characteristics:

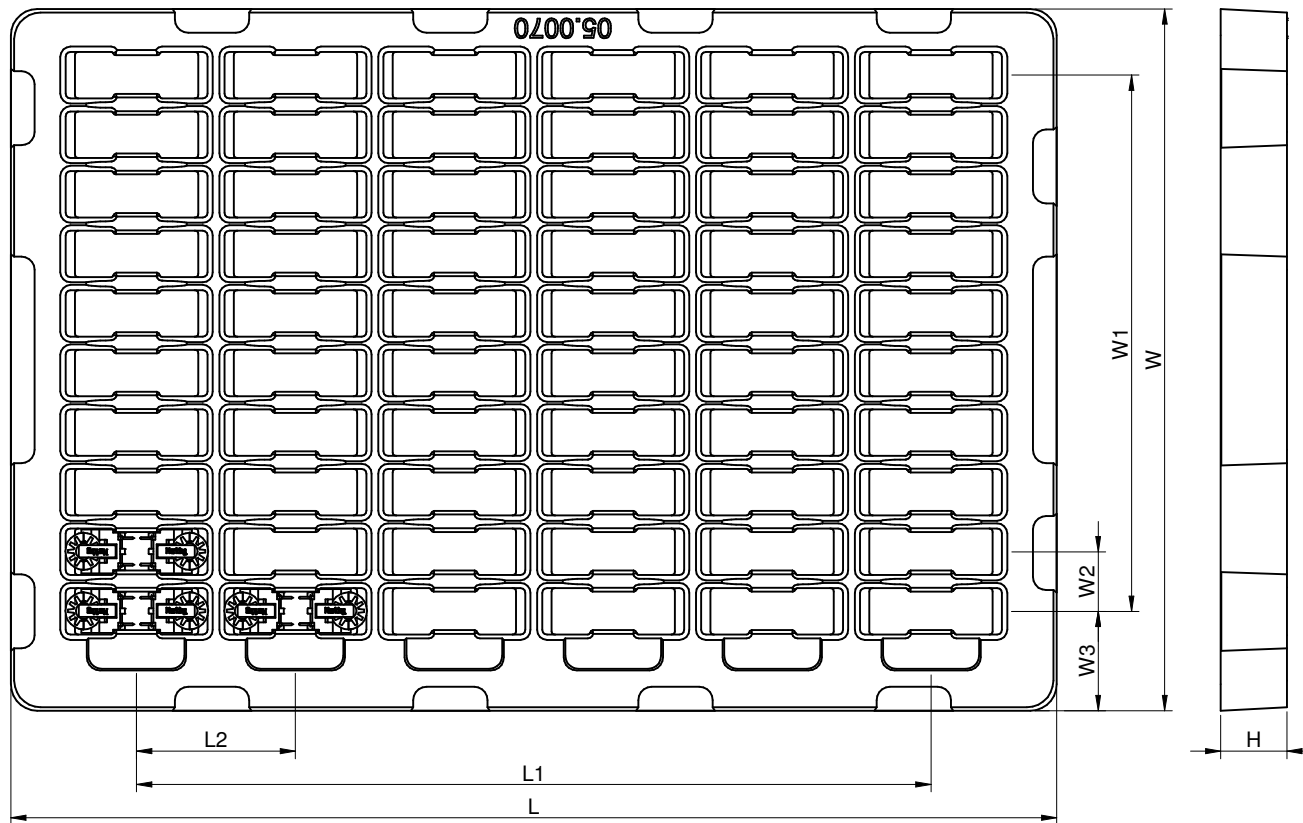

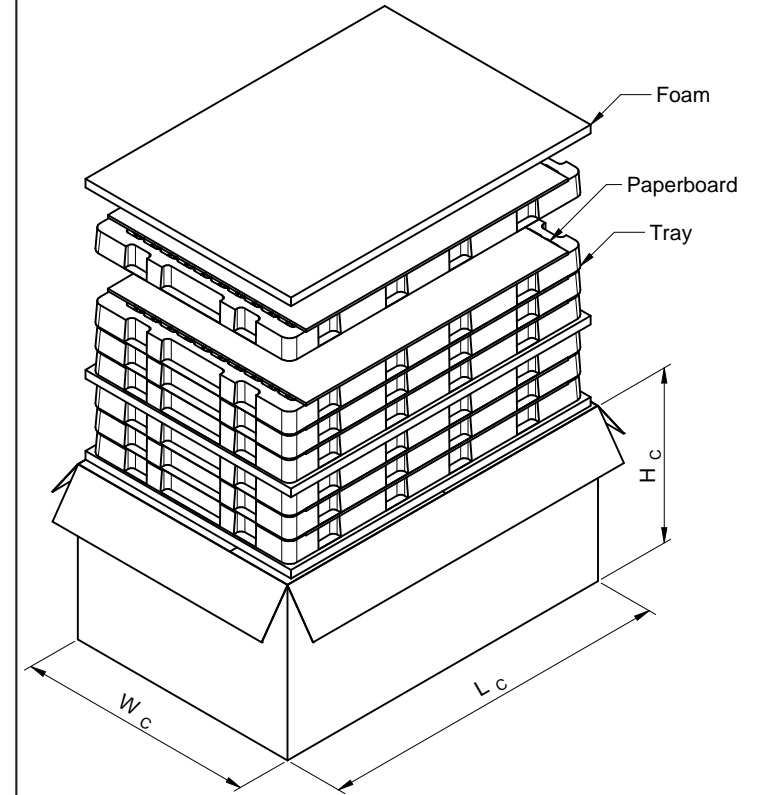



## Storage Conditions:


