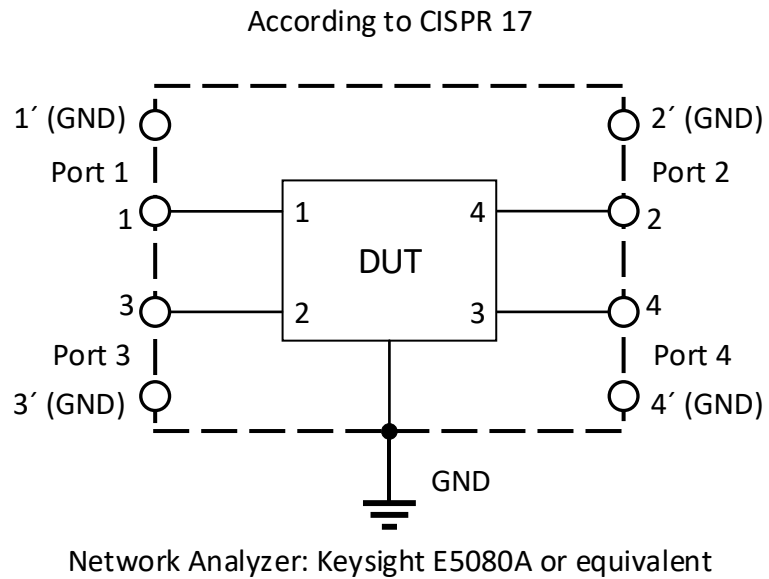


### Typical Impedance Characteristics:

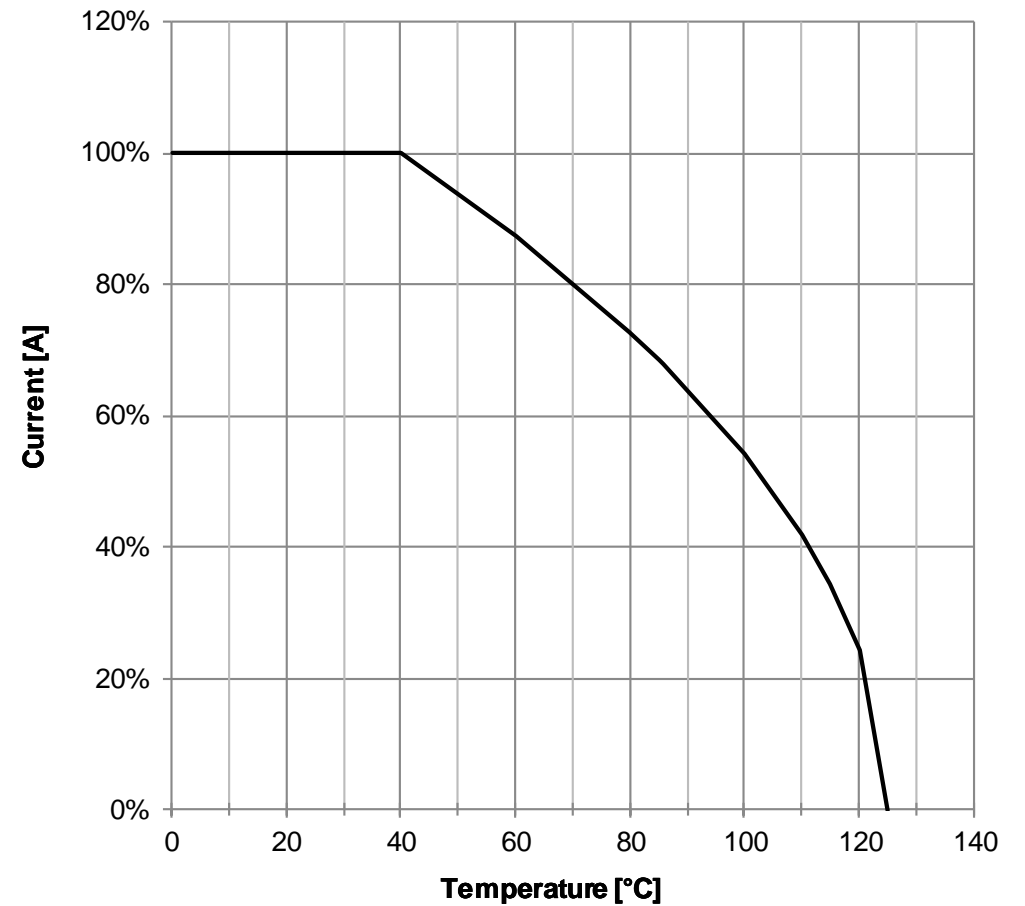

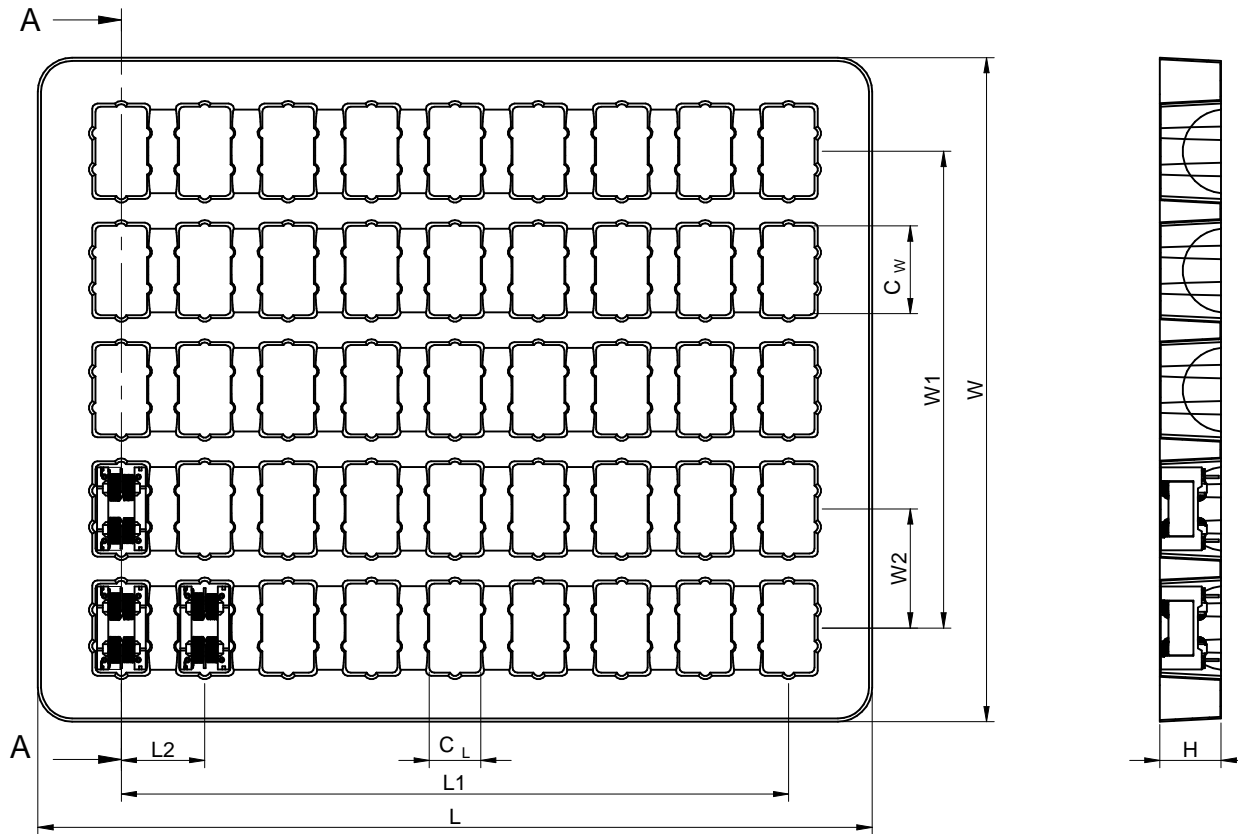


### Derating Curve:



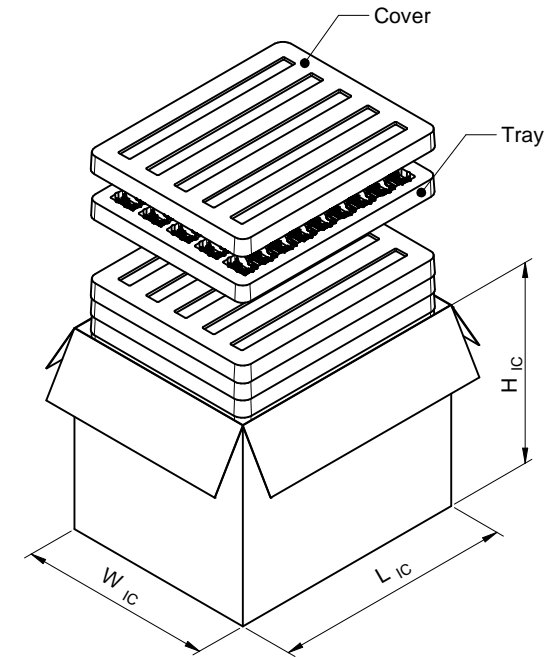





#### Packaging:


